

2022 Season Items to Note

- House wren fledges were up from 2022. The Bluebird Society of PA asks all monitors to aim to reduce house wren use of bluebird nest boxes.
- Chickadee fledges up from 6 in 2021 to 38 in 2022.
- Box monitoring personnel changes:
 - Barbara and Alan Mennig retired from their activities at White Horse Village. Elaine Sams began leading the monitoring committee there this season.
 - After this season, Kylius Jones is retiring from his monitoring at Aronomink Golf Course. The monitoring efforts will be assumed by Rich Reimers, a member of the course staff.

Future Considerations for 2023 Season

- Make any necessary Repairs/replacements/relocations in the early spring. Monitors: please make a list of your box repair/replacement needs and we'll make a plan for the early spring to address.
- Reduce house wren nest box usage in 2023. If certain nests routinely attract house wrens, we should relocate the box, remove the box, remove wren nesting material when no eggs.
- Add more nest boxes and sites to the DE County list. This is the pending list:
 - Hildacy Preserve
 - Edgemont Township Building
 - Harvey Run Trail
 - Barrett's Meadow
 - Willows Park Preserve
